REVIEW MINUTES

Bev reviewed the minutes from the March 20, 2024 meeting. Minutes accepted as read.

HERITAGE DAYS

The Board members previewed what we do for our booth for Spencer. It was suggested that we have a survey for people to voice their ideas on how the RAP tax could be spent. We should also have some brochures to hand out explaining the RAP tax. Brooke said she would get the small discs for the disc golf demo. Bev will contact Weber Basin regarding "freebees" and Terry said he would go pick up anything they have. The Board said we would work the booth both days. Russell said he could work late Friday and early Saturday, Bev will be there both days, and Terry can be there any time (after the parade on Saturday).
